

Thank you! We appreciate your diligent attention and care in reviewing your accounts and financial transactions during the 2023 fiscal year. We greatly value your efforts. Throughout the year, we observed a total of 17,456 additional journal entries resulting from corrections, department reclassifications, and cost transfers. However, we are pleased to note that these entries were more evenly distributed across the year, making the final quarter of 2023 much more manageable for departments, finance centers, and financial reporting.
